## Terms and Conditions

**Pricing:** \$4,495.00 P/P based on double occupancy, includes group air value of \$1,500. Single supplement add \$1320. Deduct \$1500 if not using group air program.

**Deposit & payment policy:**

\$1,150.00 per person deposit due with registration of tour (\$100 of initial deposit is non refundable)

\$1,150.00 per person additional payment due November 1, 2022

\$1,150.00 per person additional payment due January 1, 2023

\$1045.00 per person Final payment due: March 1, 2023

**Cancellation & Refund Policy:** must be received by written or E-mail notification to "heidifigg@ccv.church "

Cancellation policy: after December 24, 2022 receives a penalty of \$250 per person

Cancellation policy: after January 24, 2023 receives a penalty of \$500 per person

Cancellation policy: after February 24, 2023 receives a penalty of 50% of total price per person

Cancellation policy: after March 24, 2023 to departure receives a penalty of 100% of total price per person

**Travel insurance:**

Travel insurance is not included in your tour price. The Church recommends the purchase of cancellation travel insurance for this tour. **Travel insurance should be purchased within 14 days of your initial deposit to take full advantage of the benefits included in the policy.**

**Land & Tour Arrangements:** The tour operator (Phoenix Travel Group, Inc.) reserves the right to change the itinerary due to unforeseen circumstances. In all cases, the tour operator will do its best to maintain the content of the tour. The tour operator reserves the right to change the hotels listed on the tour for others of similar quality if necessary.
